This is a tricky field: You must always carefully check which address is in your accommodation contract and put the present address there. You must always come to the Mol with your present accommodation contract. You may bring your future accommodation contracts but the officers tend to disregard them.

Ex:

Your Mol appointment is on May 22., 2024. Your visa or residence card ends on August 31, 2024.

Your accommodaton contract (1) ends on June 18, 2024 . You have a summer accommodation contract (2) from June 17 to August 31, 2024. And you have a new accommodation contract (3) for the next academic year starting from September 1, 2024 to August 31, 2025.

On each of the three accommodation contracts, there is a different address (this happens with the dormitory contracts).

To make it absolutely correct, you must enter your contract (1) address, because it gives your present address. On June 17 – at least a day before expiration of the present contract you must send per post an information of change form with the second accommodation contract (2) and a day before its expiration at latest, i.e. on August 30, 2024 you must send a new information on change with the accommodation contract (3).

It is simple, isn't it? Have fun.
